Welcome to the <u>WWW.ZIRCONWALLET.COM</u> website. By using and accessing the ZIRCON WALLET website or mobile application, you agree to be bound by the following Terms and Conditions, further acknowledging that this website is owned by the company DJMV S.A.S., nit 901.421.936-3.

## 1. DESCRIPTION OF THE WEBSITE.

The user may not modify, copy, distribute, transmit, display, reproduce, publish, license, create derivative works, transfer or sell any information obtained from any of the Websites or the ZIRCON WALLET app. If you breach any of these Terms, your authorization to use this Site will automatically terminate and you must immediately destroy any downloaded or printed materials.

The provisions of the preceding paragraph will be applicable and will extend to all those third-party Websites with which ZIRCON WALLET has commercial agreements.



# 2. ACCEPTANCE OF TERMS

As long as the balance in your wallet is greater than any minimum balance requirement necessary to satisfy any transaction, you can transfer any amount of funds, up to the total amount of funds available in your ZIRCON WALLET account, less fees and commissions. charged by ZIRCON WALLET for such transactions.

ZIRCON WALLET at its sole discretion, may reject any request to withdraw funds in the event that it considers that there is any movement that compromises the security of the transaction, or that it is a suspicious movement in terms of fraud or that violates our AML policy. (Against money laundering). In this case, ZIRCON WALLET will notify the user through electronic means about the cancellation of the request. In case the request is approved, ZIRCON WALLET will take up to five (5) business days to make the requested withdrawal.

In some cases, the external wallet may reject your funds or it may not be available in another way. You agree that ZIRCON WALLET will not be liable for any costs or damages resulting from such transactions rejected by third parties.



You acknowledge and agree as a user that: (a) ZIRCON WALLET is not acting as your broker, intermediary, agent, or advisor or in any fiduciary capacity, and (b) no communication or information provided to you by ZIRCON WALLET will be considered or interpreted as advice or advice.
